



## **JAGUAR ANNOUNCES ACQUISITION OF ADDITIONAL EQUITY INTEREST IN VIRTEK**

TORONTO, CANADA – September 9, 2008 – Jaguar Financial Corporation (“**Jaguar**”) (TSX: JFC) announced its acquisition of an additional 811,300 common shares of Virtek Vision International Inc. (“**Virtek**”; TSX: VRK) representing approximately 2.4% of the total issued common shares of Virtek. The Virtek shares were acquired on the Toronto Stock Exchange for investment purposes at an average price of \$1.037 per share. Combined with the Virtek common shares previously owned, Jaguar now owns a total of 6,681,200 common shares, representing approximately 19.9% of the total issued common shares of Virtek.

Jaguar believes the common shares of Virtek are undervalued and wishes to assist in the enhancement of shareholder value.
